For the first time, the PPLC will be playing a significant role in the CIWP creation process this year. We've never done this before.	Generate preliminary ideas for how the PPLC can be an effective part of the process	→
The end of the semester brings pressure to, in a very short amount of time, address students who are failing classes. It feels like an emergency triage situation with no good options.	GLTs implement a common protocol for discussing students to be used regularly during meetings. Stoplight Report data might be useful for this. The goal is for coordinated intervention plans for students (esp. Tier 2 and Tier 3) to begin early in the semester.	→
There is a push for AP classes at Sullivan.	The PPLC should weigh in on this decision/process.	→
